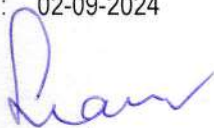


**MINUTES OF E-ELIGIBILITY BID APPROVAL CWC-I MEETING HELD ON

Hence the subject case falls under the financial powers of CWC-I).

- 08 Advance Processing Sanction : Due to Urgency of the Work, Sanction of CGM / HVF has been obtained vide CEO note Dt. 20-08-2024 to go ahead with the tendering process awaiting ADP Approval from AVNL. However only after the receipt of formal approval from AVNL CO in the form of ADP approval the tender will be finalized. The above procedure is being resorted to based on emergency works and urgency as the work out to be executed for installation of the machineries and start the ERP function requirement of AVNL CO,Avadi.

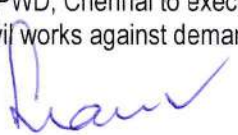
- 15 Now, AVNL CO vide letter No. AVNLCO/ENGG/Civil/ADP/ND2419 & 2420/2024-25, Dt. 20-11-2024 has intimated that HVF had submitted the following two Capital Civil works for Approval of ADP 2024-25 ;

The letter further states that HVF is having MOU with CPWD, Chennai to execute the civil works. Hence, the Competent Authority of AVNL CO has directed HVF to execute the civil works against demand No. ND2419 & ND 2420 through CPWD, Chennai.

16 **OBSERVATIONS OF CWC-I HELD ON 30-11-2024 :**

- a CWC-I observed that due to Urgency of the Work, Sanction of CGM / HVF was obtained vide CEO note Dt. 20-08-2024 to go ahead with the tendering process awaiting ADP Approval from AVNL. The e-eligibility bids have been opened on 03-10-2024 and the case was kept pending awaiting formal approval from AVNL CO in the form of ADP approval for further processing.
- b CWC-I further observed that now AVNL CO vide their letter Dt. AVNLCO/ENGG/Civil/ADP/ND2419 & 2420/2024-25, Dt. 20-11-2024 has intimated that HVF is having MOU with CPWD, Chennai to execute the civil works. Hence, the Competent Authority of AVNL CO has directed HVF to execute the civil works against demand No. ND2419 & ND 2420 through CPWD, Chennai.

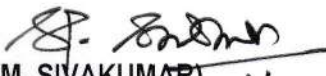
17 DECISIONS OF CWC-I HELD ON 30-11-2024 :

- b CWC-I further decided that the present e-tender for the aforesaid work (ND 2419) which is under process at HVF, bearing Tender ID : 2024\_AVNL\_206552\_1 must be cancelled in the e-procurement portal.
