The CPBG/SD should be either in the form of a Bank Guarantee (including e-bank guarantee through SWIFT Platform), demand draft (DD), Insurance Security Bond, Online Banking Transaction, Fixed Deposit Receipt, Bankers' cheque and Letter of Credit [in favour of "GAIL INDIA LTD RAJAHMUNDRI"].
