REASON FOR REJECTION:

[1/4] M/s. Sandeep Builders:

Technical Reasons: None of the documents submitted by the bidder in support of BEC-technical criteria of the tender. As such bidder is not meeting BEC-technical criteria of the tender.

Commercial Reasons: None of the documents submitted by the bidder in support of BEC-Financial criteria of the tender. Also, EMD has not been submitted by the bidder rather sought exemption under MSE category, however, those exemption are not applicable in the instant tender.

In view of the above stated reasons, bid is not acceptable techno-commercially.

[4/4] M/s. Shri Morvinandan Enterprises LLP:

Technical Reasons: Bidder has submitted the following documents in support of BEC-Technical criteria

- LOA no. GAIL/VH/20/C039/5300033898/C&P/CIVIL/YS dated 28/12/2020 issued by GAIL, Vijaipur for the Works Repairing of D type Quarters of car parking at Gail Township Phase 1 & 2 Vijaipur and its completion certificate having executed value of Rs.84,04,309.94/- (incl. GST).
- LOA no. GAIL/SR20109186/5300039202/C-42/SKK dated –19/07/2023 issued by M/s GAIL, Rajahmundry for the Works Contract for procurement & Installation of Modular Kitchen facilities in the residential quarters of Godavari Vihar Township of GAIL Rajahmundry and its completion certificate.
- LOA no. GAIL/17583/CIVI/5300040982/C-48/23/SKK dated –13/04/2024 issued by M/s GAIL, Rajahmundry for the Contract for construction of multipurpose box court at Godavari Vihar Township of KG basin.

However, work orders referred at S.No ii to iv above does not contain the SOR item works like Flooring/ False ceiling/wall panelling/air conditioning (HVAC) etc to substantiate BEC-technical criteria of the tender and work order referred at S.No i

above does contain SOR item of Flooring but total executed value of the contract is only Rs.84.04 lakhs inclusive of taxes against tender requirement of Rs. 96.50 lakhs inclusive of taxes under single work order category. As such bidder is not meeting BEC-technical criteria of the tender.

Commercial Reasons: EMD has not been submitted by the bidder rather sought exemption under MSE/Startup category, however, exemption of EMD under MSE/start-up category is not applicable in the instant tender.

In view of the above stated reasons, bid is not acceptable techno-commercially.
