**(4) Observation of TEC:**

**(a) M/s MILAN MARINE SERVICE**

The financial bid of technically qualified bidder M/s MILAN MARINE SERVICE was opened on 26.02.2024. On scrutiny based on the comparative statement it is observed that M/s MILAN MARINE SERVICE (L-2) has quoted Rs. 17,55,360.00/- which is higher (+6.00%) then the estimated cost.

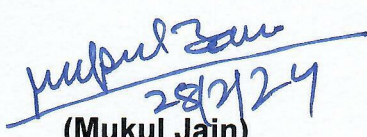
**(b) M/s RUPNARAYAN MARINE WORKS**

The financial bid of technically qualified bidder M/s RUPNARAYAN MARINE WORKS was opened on 26.02.2024. On scrutiny based on the comparative statement it is observed that M/s RUPNARAYAN MARINE WORKS (L-1) has quoted Rs. 17,36,316.00/- which is higher (+4.85%) then the estimated cost.

**(5) TEC Recommendation:**

R.O. Kolkata TEC, scrutinized the bids of two(2) technically qualified bidder and observed that M/s RUPNARAYAN MARINE WORKS is L-1 bidder has quoted Rs. 17,36,316.00/- plus GST and cost of spare on actual plus 10% basis which is higher (+4.85%) then estimated cost Rs.16,56,000.00/-.

TEC recommends that work may be awarded to L-1 bidder i.e. M/s RUPNARAYAN MARINE WORKS at the quoted price of Rs. 17,36,316.00/- (excluding GST) plus cost of spare on actual +10% basis with approval of the approval of Competent Authority.
