(4) Observation of TEC:

(a) M/S Maa Vindhya wasni Enterprises

On scrutiny it is observed that M/S Maa Vindhya wasni Enterprises has submitted all the relevant documents in support of their MSME registration, detail Audited balance sheet, solvency certificate, experience in similar works, and similar work completion certificate **except** the evidence of yard details. Therefore the firm may not be considered for technical qualification.

(b) M/S GHOSH ENTERPRISE

On scrutiny it is observed that M/S GHOSH ENTERPRISE has submitted all the relevant documents in support of their MSME registration, detail Audited balance sheet, experience in similar works, and similar work completion certificate **except** valid solvency certificate. Therefore the firm may not be considered for technical qualification.

(c) **M/S A C ROY SHIPBUILDERS PRIVATE LIMITED**

On scrutiny it is observed that M/S A C ROY SHIPBUILDERS PRIVATE LIMITED has submitted all the relevant documents in support of their MSME registration, detail Audited balance sheet, solvency certificate, experience in similar works, and similar work completion certificate **except** the valid solvency certificate. Therefore the firm may not be considered for technical qualification.

(d) **M/s ATREYA SHIPYARD PRIVATE LIMITED**

On scrutiny it is observed that M/s ATREYA SHIPYARD PRIVATE LIMITED has not submitted many documents likes, i) ESI certificate ii) Details of Tools, Plant iii) Authority for signing of the tender, iv) Work experience with any Govt. work etc. for qualify in technical bid. Therefore the firm may not be considered for technical qualification.

(e) **M/S MILAN MARINE SERVICE**

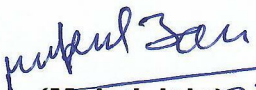

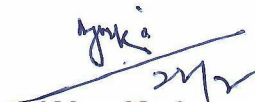
(f) **M/S RUPNARAYAN MARINE WORKS**
