**(4) Observation of TEC:**

**(a) M/s Maa Vindhyawasni Enterprises**

The financial bid of technically qualified bidder M/s Maa Vindhyawasni Enterprises was opened on 26.02.2024. On scrutiny based on the comparative statement it is observed that M/s Maa Vindhyawasni Enterprises (L-2) has quoted Rs. 2,51,545.00/- which is lower (-1.20%) then the estimated cost.

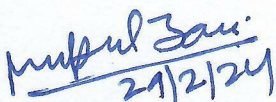
**(b) M/s S.I.M. COMPANY**

The financial bid of technically qualified bidder M/s S.I.M. COMPANY was opened on 26.02.2024. On scrutiny based on the comparative statement it is observed that M/s S.I.M. COMPANY (L-1) has quoted Rs. 2,26,594.00/- which is lower (-11.00%) then the estimated cost.

**(5) TEC Recommendation:**

R.O. Kolkata TEC, scrutinized the bids of two(2) technically qualified bidder and observed that M/s S.I.M. COMPANY is L-1 bidder has quoted Rs. 2,26,594.00/- plus GST which is lower (-11.00%) then estimated cost Rs.2,54,600.00/-

TEC recommends that work may be awarded to L-1 bidder i.e.S.I.M. COMPANY at the quoted price of Rs. 2,26,594.00/- (excluding GST) with approval of the Competent Authority.
