2. M/s Shasi Enterprises failure to submit the firm registration document and similar experience

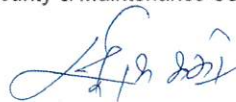
The Technical Bid of the e-tender was opened at the scheduled time 13.30 hours on 06.03.2024 and found that four firms has been participated in the online bid process i.e., **M/s Sharp Thrill Investigation & Flint Force Private - New Delhi, M/s Shasi Enterprises - Vishakapatnam, M/s Shakti Security & Maintenance Services Pvt. Ltd. - Secunderabad and M/s PAN INDIA - Hyderabad.** On scrutinizing the documents submitted by the bidders, the TEC found that the below two bidders has not furnished all the requisite documents to satisfy the Check List prescribed for Technical bid evaluation process and found technically disqualified.

1. M/s Sharp Thrill Investigation & Flint Force Private submitted the fabricated documents in the experience certificate.
2. M/s Shasi Enterprises has not submitted the firm registration document and similar technical experience.

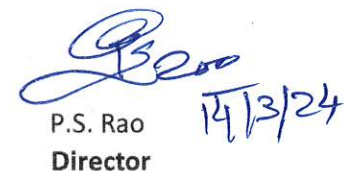
