2.0 RESPONSE TO "NIT"

This was a 2nd call for tender, earlier tender was cancelled as both the bidders have a common director.

The bidding was open to all the firms having experience in "design, construction, supply, installation, testing and commissioning of floating concrete Jetties duly certified by IR Class or any IACS body". The following 3 firms evinced interest in the bids.

- a) M/s REL MARINETEK INFRA PVT. LTD., Goa
- b) M/s Pruthvi Infrastructures, Kodinar, Gujarat
- c) M/s A to Z Exim, Mumbai.

3.0 BID EVALUATION

The bid submission portal reflects all the 3 bidders, however after downloading the bids, it was observed that the bid of M/s A to Z Exim were corrupt (Annex-A) . The firm also checked the same and forwarded the screenshots of the issue (Annex-B). The firm later on contacted e-procurement portal and they also highlighted that the issue is at the end of the bidder (Annex-C), the e-procure portal however reported that the error is not on the part of e-procure in addition, IWA forwarded emails to e-procure which has not been replied till date. The downloading of bids were also demonstrated before TEC which also returned the same error (Annex-A). For both the other bidders, the bids were downloaded and has been considered for evaluation. The bid for M/s A to Z Exim has been considered as non-responsive.

After ascertaining payment of tender cost and EMD and/or submission of valid MSME certificate by the bidders, their technical bids were opened and evaluated as per the criteria laid down in the Tender document:

3.1 Technical Evaluation

The following technical observations has been made wrt to the qualification criteria

- a) M/s REL Marinetek Infra Pvt Ltd(Annex-D) - The firm fulfills all the eligibility criteria as laid in the tender document.
- b) M/s Pruthvi Infrastructures (Annex-E) - The firm fulfills all the eligibility criteria as laid in the tender document.

4.0 EVALUATION RESULT

Based on the submissions the following 2 bidders are found technically qualified

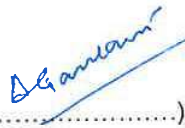
- a) M/s REL Marinetek Infra Pvt Ltd and ;

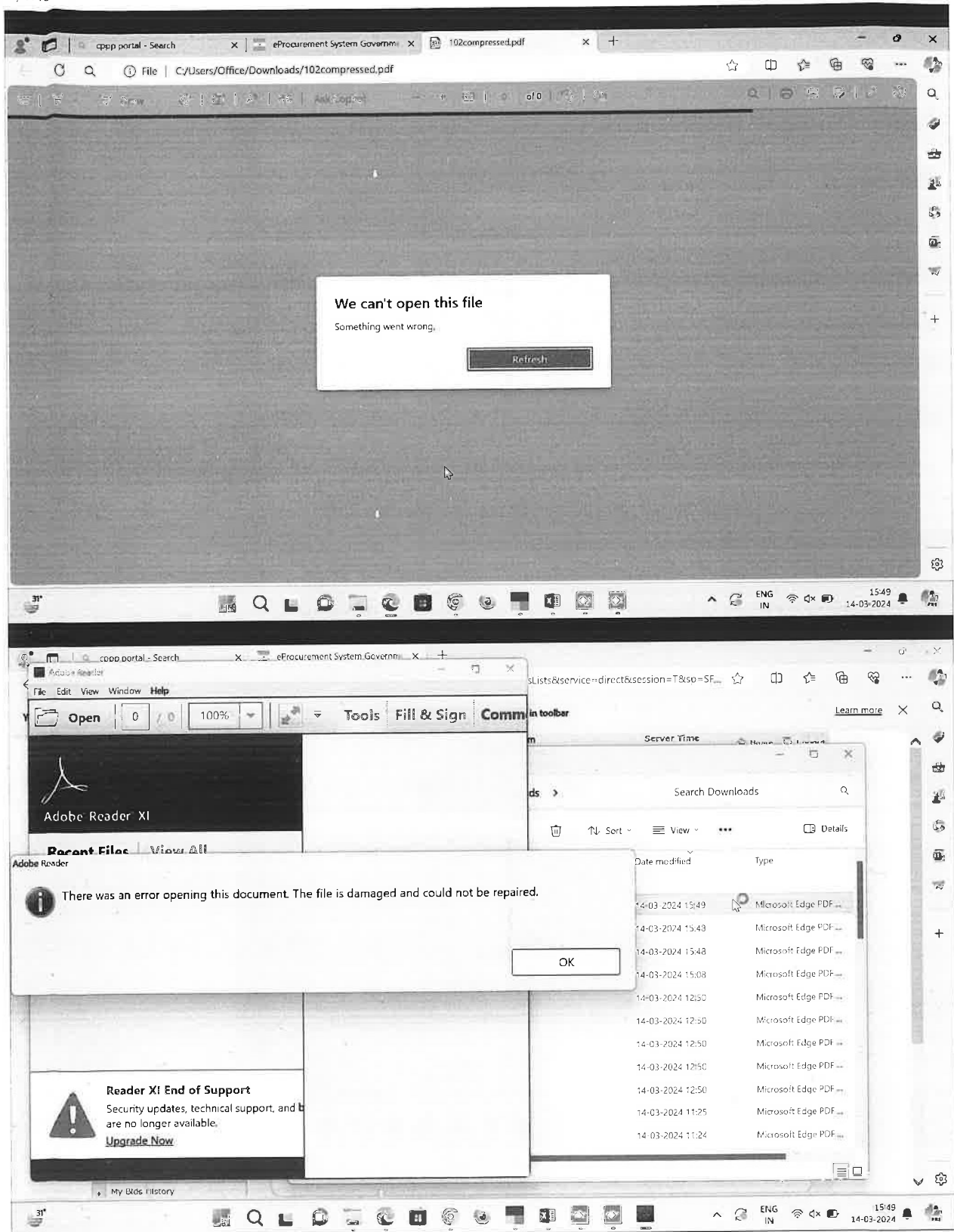

Note for TEC

1. The tender for "Design, Construction, Supply, Installation, Testing & Commissioning of 10 nos Community Jetties in State of Goa was floated.
2. 3 firms participated in bidding process
 - a) M/s A to Z Exim, Mumbai
 - b) M/s REL Marinetek Pvt Ltd, Goa
 - c) M/s Pruthvi Infrastructures, Kodinar Gujarat.
3. The bids of all 3 bidders were downloaded. Each bidder has submitted 5 technical packets. In case of M/s A to Z Exim, only 1 packet opened correctly, rest of the packets were corrupt.
4. M/s A to Z Exim also noticed 4 packets are corrupt in their bid submission and they forwarded an email to e-procure with a copy to IWAI alongwith the relevant screenshots.
5. The said was brought to the knowledge of TEC and as per their repeated emails has been sent to e-procure to ascertain if the bids are corrupt at their end too. However, till date e-procure has not responded.
6. In this regard, it is for submission to TEC
 - a) The bids have been downloaded in other systems also and the same has been demonstrated before the Chairman of TEC also. The same problem persists.
 - b) If the issue would have been on the part of e-procure, then 1 packet would not have opened correctly.
 - c) The other 4 packets would have been corrupt at the end of up- loader i.e. M/s A to Z Exim. The other bids were downloaded and the files were intact.
