In case of extension of contract period, the Contractor shall get the validity of the Performance Bank Guarantee extended to cover such extension of time of the work.
- 4) The total Security Deposit shall remain with IWAI, Vijayawada till completion of the contract or the payment of the final bill payable in accordance with agreement conditions whichever is later, provided the E-I-C is satisfied that there is no demand outstanding against the Contractor. No interest will be paid on Security Deposit or Performance Guarantee.
- 5) The contractor shall submit the invoice in Triplicate along with the previous month GST returns on completion of Monthly Longitudinal Thalweg survey along with monthly final survey data, survey charts and survey report as per Part - III, Technical & Special conditions of the tender subject to acceptance of the Engineer-In-Charge.
- 6) Statutory Tax as applicable rates shall be deducted at source from any payment made to the contractor against this contract.
