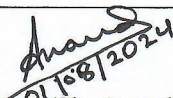

(4) TEC Recommendation after opening of technical bid :

As per the NIT, the tender documents were to be submitted on line by the bidder to Director, IWAI, Kolkata on or before 16-07-2024 upto 15.00 hrs. and to be opened on 17-07-2024 at 15.30 hrs. Accordingly, the technical bids were opened of 24-06-2024 at 11.30 hrs. After opening of technical bids, it is observed that M/s The Indian Overseas Trading Company, M/s S.R Electricals, M/s Olive Exports Pvt. Ltd., M/s GJP Enterprise and M/s Sim Company have participated in this tender. Further, on scrutiny of document submitted above bidder, following is observed by TEC with respect to above bidders:

(1/5) M/s The Indian Overseas Trading Co.	:	M/s The Indian Overseas Trading Company have submitted all the documents as per technical parameters mentioned except undertaking with respect to not banned/blacklisted of the firm. Further, it is also observed by the TEC that the firm has submitted 2 nos of Power of Attorney and as per both of the PoA documents submitted by them are not signed by the authorized person, hence TEC recommends him as technically disqualified bidder for this tender.
(2/5) M/s S.R Electricals	:	M/s S.R Electricals has submitted all the documents as per technical parameters mentioned except entire bid document duly signed & stamped, PAN card and undertaking with respect to no-alteration. Further, it is also observed by TEC that the firm has altered the tender document, hence TEC recommends him as technically disqualified bidder for this tender.
(3/5) M/s Olive Exports Pvt. Ltd.	:	M/s Olive Exports Pvt. Ltd. have submitted all the documents as per technical parameters mentioned except undertaking with respect to not banned/blacklisted of the firm & no-alteration in bid document, hence TEC recommends them as technically disqualified bidder for this tender.

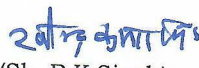

(5/5) M/s Sim Company	:	M/s Sim Company has submitted all the documents as per technical parameters mentioned & TEC recommends them as technically qualified bidder for this tender.

From above, it is observed that 5(five) nos of bidders naming (1/5) M/s The Indian Overseas Trading Company, (2/5) M/s S.R Electricals, (3/5) M/s Olive Exports Pvt. Ltd., (4/5) M/s GJP Enterprise & (5/5) M/s Sim Company have participated in this tender. After scrutinizing the technical documents submitted by these bidders, it is observed by TEC that 2nos(Two) bidders naming M/s GJP Enterprise & M/s Sim Company have submitted/fulfilled all the technical parameters mentioned in the tender document, hence TEC recommends them as technically qualified bidders for this.
