

Recommendation of TEC on E-tender for "Development & Maintenance of Navigational Channel (Fairway) in Neamati - Dibrugarh Stretch of NW 2"

The statement of the technical evaluation sheets before shortfall and after shortfall are enclosed as Annex-I & II.

3. Observations and Recommendation of TEC

(a) As per the NIT, the tender documents were to be submitted online by the bidder to Director, IWAI, Guwahati on or before 15.07.2024 upto 15.00 hrs and to be opened on 16.07.2024 at 15.30 hrs. Accordingly, the technical bids were opened on 18.07.2024 at 15.30 hrs. After scrutiny of documents it is observed by the TEC that 1(one) bidder viz. (2/2) **Dinesh Prasad Sharma** has some shortfall documents and the same were asked to submit shortfall documents to be submitted online in the CPP portal on or before 27.07.2024 15:00 hrs and was opened on 27.07.2024. After scrutiny of the shortfall documents the following is observed by the TEC.

(b) **Dinesh Prasad Sharma** has submitted all the requisite documents to fulfill all the technical parameters mentioned in the tender except

(i) Scanned copy of labour license from the Concerned Authority / undertaking certificate

(ii) Audited balance sheet - 2020-21.

(iii) Scanned copy of signed declaration stating that no alteration has been made in any form in the downloaded tender document is to be enclosed with the tender by the bidder for downloaded tenders

. Hence, TEC recommends to ask the above mentioned document to be submitted by the bidder in online in CPP portal on or before 27.07.2024 15:00 hrs. Accordingly, **Dinesh Prasad Sharma** has submitted the required above shortfall document as asked by the TEC. Further, he has finally submitted all the required documents to fulfil all the technical parameter mentioned in the tender document. Hence, considering above TEC recommends to him as technically qualified bidder for this tender.

Finally, TEC recommends to (1/2) **M/s Ranu Nandi** and (2/2) **Dinesh Prasad Sharma** are technically qualified bidders as they have submitted all the required documents to fulfil all the technical parameters mentioned in the tender documents.

Further, TEC recommends to open the financial bid of the above technically qualified bidders i.e. (1/2) **M/s Ranu Nandi** and (2/2) **Dinesh Prasad Sharma** on 31.07.2024
