4. Observations of TEC:-

After approval of the Competent Authority, the financial bids of above technically qualified firms were opened on 22.7.2024 at 11:00 AM by the TEC. The comparative statement of the financial bids has been prepared and is enclosed herewith.

The prices quoted by each firm are given below:

As per comparative statement, it is observed that M/s Das Consultancy & agency service has quoted 4.74 % excess to the estimated cost and is L-1. The statement / comparative statement is attached as Annex-I.



In context above, a letter no. DCAS/IWAI/Mandovi/2024-25/007 dated 23.7.2024 has been received from M/s Das Consultancy & agency service stated that, due to unavoidable circumstances, the firm is unable to execute the annual repair work of CSD Mandovi and the firm has submitted letter to withdraw the bid and has requested to cancel the participation on the above said tender.

Therefore, M/s Ghosh Enterprise, as L-2 bidder was asked to submit their willingness of negotiation to this office to carry out the work within or below the estimated cost.

Accordingly, M/s Ghosh Enterprise has submitted their negotiate rate vide e-mail dated 5.8.2024 to carry out the work at the cost of **Rs.6,75,700/- i.e., 0.04% below the estimated cost.**

5. Recommendation of TEC:-

In view of above, TEC opined that the work for "Annual afloat repair of IWAI vessel CSD Mandovi for the year 2024-25" may be awarded to M/s Ghosh Enterprise being lowest bidder among all.
