(4) Observation of TEC:

(a) M/s French Enterprise

On scrutiny after opening of the financial bid of technical qualified bidder M/s French Enterprise based on the comparative statement it is observed that M/s French Enterprise has (L-1) has quoted Rs. 12,52,290.57 /- say Rs. 12,52,291.00/- which is lower (-7.00%) than the estimated cost.

(b) M/s GHOSH ENTERPRISE

On scrutiny after opening of the financial bid of technical qualified bidder M/s GHOSH ENTERPRISE based on the comparative statement it is observed that M/s GHOSH ENTERPRISE has (L-2) has quoted Rs. 14,27,341.94 /- say Rs. 14,27,342.00/- which is higher (6.00%) than the estimated cost.

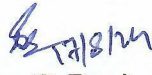

(5) **TEC Recommendation:**

R.O. Kolkata TEC, scrutinized the bids of two (2) technically qualified bidder and observed that M/s FRENCH ENTERPRISE is L-1 bidder has quoted Rs.12,52,291.00 /- plus GST and cost of spare on actual plus 10% basis which is lower (- 7.00%) then estimated cost.

TEC recommends that work may be awarded to L-1 bidder i.e. M/s FRENCH ENTERPRISE at the quoted price of Rs.12,52,291.00/- (excluding GST) plus cost of spare on actual +10% basis with approval of Competent Authority.
