3. Observations and Recommendation of TEC :

As per the NIT, the tender documents were to be submitted online by the bidder to Director, IWAI, Guwahati on or before 17.8.2024 upto 15.00 hrs. and to be opened on 19.8.2024 at 15.30 hrs. Accordingly, the technical bids were opened on 19.8.2024 at 15.30 hrs. After scrutiny of documents it is observed that 3(Three) bidders have submitted their bids for this tender and the details are as follows:

- (1/3) **M/s Dinesh Prasad Sharma** has submitted all the requisite documents to fulfill all the technical parameters mentioned in the tender. Hence, TEC has considered him as a technically qualified bidder.
- (2/3) **M/s Ranu Nandi** has submitted all the requisite documents to fulfill all the technical parameters mentioned in the tender. Hence, TEC has considered him as a technically qualified bidder.
- (3/3) **M/s Luit Constructions** has submitted all the requisite documents to fulfill all the technical parameters mentioned in the tender. Hence, TEC has considered him as a technically qualified bidder.

Finally, TEC recommends (1/3) M/s Dinesh Prasad Sharma, (2/3) M/s Ranu Nandi and (3/3) M/s Luit Constructions as technically qualified bidders as they have submitted all the requisite documents to fulfill all the technical parameters as mentioned in the tender document.

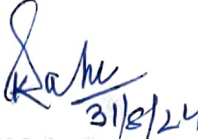

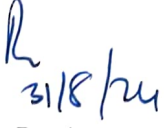
