(4) Observation of TEC:

(a) M/s French Enterprise

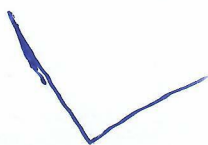
On scrutiny after opening of the financial bid of technical qualified bidder M/s French Enterprise based on the comparative statement it is observed that M/s French Enterprise (L-2) has quoted Rs. 5,41,442 /- which is lower (+5.00%) of the estimated cost.

(b) M/s Ghosh Enterprises

On scrutiny after opening of the financial bid of technical qualified bidder M/s Ghosh Enterprises based on the comparative statement it is observed that M/s Ghosh Enterprises (L-2) has quoted Rs. 5,41,442 /- which is lower (+5.00%) of the estimated cost.

(c) M/s Maa Vindhyawasani Enterprises

On scrutiny after opening of the financial bid of technical qualified bidder M/s Maa Vindhyawasani Enterprises based on the comparative statement it is observed that M/s Maa Vindhyawasani Enterprises (L-1) has quoted Rs. 5,13,081 /- which is lower (-0.50%) of the estimated cost.

(5) **TEC Recommendation:**

R.O. Kolkata TEC, scrutinized the bids of three (3) technically qualified bidders and observed that M/s Maa Vindhyaawasani Enterprises is L-1 bidder has quoted Rs. 5,13,081/- plus GST and cost of spare on actual plus 10% basis which is lower (-0.50%) of the estimated cost.

TEC recommends that work may be awarded to L-1 bidder i.e. M/s Maa Vindhyaawasani Enterprises at the quoted price of Rs. 5,13,081/- (excluding GST) plus cost of spare on actual +10% basis with approval of Competent Authority.
