(4) TEC Recommendation after opening of shortfall of technical bid :

As per the NIT, the tender documents were to be submitted on line by the bidder to Director, IWAI, Kolkata on or before 17-08-2024 upto 15.00 hrs. and to be opened on 19-08-2024 at 15.30 hrs. Accordingly, the technical bids were opened of 19-08-2024 at 15.30 hrs. After opening of technical bids, it is observed that 3 nos (Three) of bidders naming (1/3) M/s Hareram Shrama, (2/3) M/s Sim Company & (3/3) M/s RMS ENTERPRISE have participated in this tender. Further, on scrutiny of document submitted above bidder, it is following is observed by TEC with respect to above bidders:

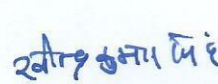
(1/3) M/s Hareram Shrama	:	M/s Hareram Shrama has submitted all the documents to full fill all technical parameters as mentioned in the tender document except Bank solvency & Cancelled cheque & Bank Details for E-Payment. Hence, considering above TEC recommended as technically disqualified bidder.
(2/3) M/s Sim Company	:	M/s Sim Company has submitted all the documents to full fill all technical parameters as mentioned in the tender document. Hence, TEC considered to M/s Sim Company as technically Qualified bidder.
(3/3) M/s RMS ENTERPRISE	:	M/s RMS ENTERPRISE has submitted all the documents to full fill all technical parameters as mentioned in the tender document. Hence, TEC considered to M/s RMS ENTERPRISE as technically Qualified bidder.

From above statement, it is observed by TEC that three nos of bidders naming (1/3) M/s Hareram Shrama, (2/3) M/s Sim Company & (3/3) M/s RMS ENTERPRISE have participated in this tender. On Scrutiny of documents submitted by these bidders, it is observed by TEC that two nos of bidders naming M/s Sim Company & M/s RMS ENTERPRISE has fulfilled all the technical parameters mentioned in the tender document. Hence, TEC recommends M/s Sim Company & M/s RMS ENTERPRISE as technically qualified bidder's for this tender. Further, TEC also recommends to open the financial bid of M/s Sim Company & M/s RMS ENTERPRISE as a technically qualified bidders on 24.08.2024.
