Sir,

Kindly refer to e-tender no. 2024_IWAI_823510_3 for Dry Dock repair of IWAI Pontoon CP Ganga- IV FOR THE YEAR 2024-25, we are pleased to place a work order to M/s Milan Marine Service, Kolkata at a total cost of Rs. 19,12,883.00/- (Rupees Nineteen Lakh Twelve Thousand Eight Hundred Eighty-Three Only) wherein Labour charges Rs. 18,12,883.00/- Excluding GST and cost of spares Rs 1,00,000.00/- (tentative) and excluding of GST as applicable, as per enclosed bill of quantity in accordance with the tender terms & conditions. Cost of spares on actual + 10 % basis to be paid subject to spares fitted and supplied within estimated cost. Incremental spare cost to be approved by Competent Authority.

The total cost of work shall be Rs. 19,12,883.00/- excluding of GST as applicable, as per item wise rate mentioned in the enclosed BOQ subject to variation of quantity of work actually executed and certified by the EIC. The above-mentioned total cost is inclusive of taxes, duties and other levies etc., excluding GST as specified in tender. The payment shall be made on submission of bill after certification of the E.I.C for the actual quantity executed. The work shall be completed within 60 (Sixty) days from the date of placement of vessel in the yard. As per tender Technical and Special Conditions no.11 all statutory survey by surveyor of IWT, State Government shall be arranged by the contractor on behalf of the Authority and survey fees, third-party insurance and any other endorsement/documentation as claimed by the IWT surveyor will only be reimbursed by Authority.

As per tender clause no. 18 under technical specification and special conditions, the inspection of vessels during execution of repairing of IWAI vessels shall be carried out by IRS and arranged by the contractor on behalf of the Authority. The payment of IRS visits, plate stamping and testing during repairing of the vessels at yard shall be paid by the repairer. However, this amount shall be re-imbursed to the repairer on submission of proof of bill raised by the IRS and payment made by the repairer.

You are requested to deposit an amount Rs. 95,645.00/- (Rupees Ninety-Five Thousand Six Hundred Forty-Five Only) i.e., the 5% of the contract value of the work order either in the form of RTGS/ NEFT through scheduled / nationalized banks in the favor of "Inland Waterways Authority of India Fund" payable at Kolkata (or) in the form of irrevocable bank guarantee of any scheduled bank towards performance Guarantee within 10 days of the issue of this work order as per terms & conditions of the tender document. In addition to the above, a security deposit equivalent to 5% of the contract value (i.e. Rs. 95,645.00/- (Rupees Ninety-Five Thousand Six Hundred Forty-Five Only) will be deducted from RA bills as per Clause 4 of the General Conditions of Contract.

As per tender clause no. 35 LD (liquidity damages) will be imposed accordingly.

A list of the additional work which is considered necessary as per recommendation of the EIC and or those which are directed during the course of repairs for satisfactory completion of repairs and subsequent commissioning of vessel should be prepared jointly by EIC and contractor. Thereafter, contractor shall furnish quotation for those items of work for which rate would be derived from the agreement or afresh as the case may be in force along with extra time required for completion of all the additional work. The rate for the additional work shall be approved as provided in clause No. 12 of Technical & Special Conditions of contract and clause no. 16 of the General Condition of contract for execution.

The work executed all items of work attended and spare etc. supplied by the contractor shall have Guarantee period of minimum 12 months or manufacturer warrantee whichever is more from the date of delivery of the vessel after repair.

The work plan to be submitted within 7 days of issue of work order.

An agreement shall be entered between this Authority and Firm in the approved format within 12 days from the date of receipt of work order. You are requested to attend this office with 2 non-Judicial stamp papers of Rs 100/- each for signing of contract agreement and integrity.

It is requested to convey your acceptance for this work order by signing the copy of this letter immediately.
