(4) Observation of TEC:

(a) M/S RUPNARAYAN MARINE WORKS

Upon scrutiny after the opening of the financial bid for the technically qualified bidder, M/S RUPNARAYAN MARINE WORKS, it is observed from the comparative statement that M/S RUPNARAYAN MARINE WORKS (L-2) has quoted Rs. 19,05,695.38, rounded off to Rs.19,05,695.00, which is 9.85% higher than the estimated cost.

(b) M/s MILAN MARINE SERVICE

Upon scrutiny after the opening of the financial bid for the technically qualified bidder, M/s MILAN MARINE SERVICE, it is observed from the comparative statement that M/s MILAN MARINE SERVICE (L-1) has quoted Rs. 18,12,882.72, rounded off to Rs.18,12,883.00, which is 4.50% higher than the estimated cost.

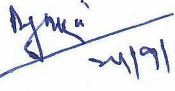

(5) **TEC Recommendation:**

R.O. Kolkata TEC, scrutinized the bids of two (2) technically qualified bidder and observed that M/s MILAN MARINE SERVICE is L-1 bidder has quoted Rs.18,12,883.00 /- plus GST and cost of spare on actual plus 10% basis which is higher (+ 4.50%) then estimated cost.

TEC recommends that work may be awarded to L-1 bidder i.e. M/s Milan Marine Service at the quoted price of Rs.18,12,883.00/- (excluding GST) plus cost of spare on actual +10% basis with approval of Competent Authority.
