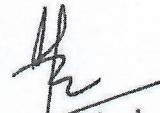

(a) M/s Merolyn Engineering Works Pvt Ltd

Upon scrutiny after the opening of the financial bid for the technically qualified bidder, M/s Merolyn Engineering Works Pvt Ltd, it is observed from the comparative statement that M/s Merolyn Engineering Works Pvt Ltd (L-1) has quoted Rs. 3,90,88,000.00/- which is 15.05 % lower than the estimated cost.

(b) M/s Nalanda Engineering Enterprise

Upon scrutiny after the opening of the financial bid for the technically qualified bidder, M/s Nalanda Engineering Enterprise, it is observed from the comparative statement that M/s Nalanda Engineering Enterprise (L-4) has quoted Rs. 4,31,10,000.00, which is 6.31 % lower than the estimated cost.

(c) M/s Patra Shipping Private Limited

Upon scrutiny after the opening of the financial bid for the technically qualified bidder, M/s Patra Shipping Private Limited, it is observed from the comparative statement that M/s Patra Shipping Private Limited (L-3) has quoted Rs. 4,22,22,222.00, which is 8.24 % lower than the estimated cost.

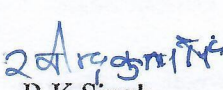
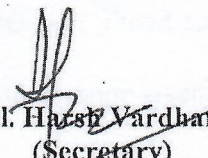
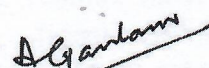
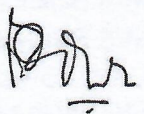
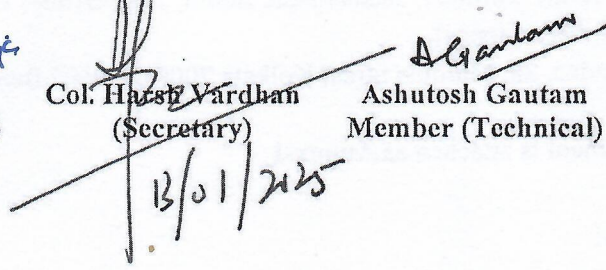
(d) M/s Milan Marine Service

Upon scrutiny after the opening of the financial bid for the technically qualified bidder, M/s Milan Marine Service, it is observed from the comparative statement that M/s Milan Marine Service (L-2) has quoted Rs. 4,17,00,786.00, which is 9.37 % lower than the estimated cost.

(6) TEC Recommendations:

After opening of the financial bid of the technically qualified bidder, it is observed that observed that M/S Merolyn Engineering Works Pvt Ltd is L-1 bidder has quoted Rs. 3,90,88,000.00/- plus GST which is lower (- 15.05 %) then estimated cost.

Tender committee recommends issuing the LoA to L1 bidder namely M/s. Merolyn Engineering Works Pvt. Ltd.
