The firm may not be considered technically qualified.

(b) M/s Milan Marine Service

On scrutiny it is observed that M/s Milan Marine Service, has submitted all the relevant documents in support of their MSME registration, Audited balance sheet, solvency certificate, except 1) Banned or de-listed declaration by any GOVT. -or Quasi Govt. agency or public sector undertaking, PSU. 2) Work completion certificate of adequate amount i.e.

- a) 3 similar works each costing not less than 40% i.e. Rs. 36.82 Lacs, or
- b) 2 similar works each costing not less than 50% i.e. Rs. 46.03 Lacs, or
- c) 1 similar works each costing not less than 80% i.e. Rs. 73.64 Lacs.

(c) M/S PATRA SHIPPING PRIVATE LIMITED
