(4) Observation of TEC:

(a) M/s PATRA SHIPPING PVT. LTD.

Upon scrutiny after the opening of the financial bid for the technically qualified bidder, M/s PATRA SHIPPING PVT. LTD., it is observed from the comparative statement that M/s PATRA SHIPPING PVT. LTD. (L-1) has quoted Rs. 38,53,691.45/-, rounded off to Rs. 38,53,691.00/-, which is 0.10% lower than the estimated cost.

(5) TEC Recommendation:

As per approval of Competent Authority, retender has been floated and technical bids opened on 28.12.2024. It is observed that only one bidder M/s Patra Shipping Pvt. Ltd. qualified technically.

The Hon'ble Minister inaugurated the Cargo Promotion Scheme and Scheduled Service on dated 15.12.2024. As the vessels are to be utilized in a fixed schedule service under a bareboat charter with M/s ICSL, it is essential to complete the dry dock repair works at the earliest.



As per approval of Competent Authority vide e-file Comp. No. 344725
Note # 190, Financial bids opened on dated 02.01.2025.

R.O. Kolkata TEC, scrutinized the bids of Only One (1) technically qualified bidder and observed that M/s PATRA SHIPPING PVT. LTD. is L-1 bidder has quoted Rs. 38,53,691.45/- say Rs. 38,53,691.00/- plus GST and cost of spare on actual plus 10% basis which is lower (- 0.10%) then estimated cost.

TEC recommends that work may be awarded to L-1 bidder i.e. M/s PATRA SHIPPING PVT. LTD. at the quoted price of Rs. 38,53,691.00/- (excluding GST) plus cost of spare on actual +10% basis.
