(4) Observation of TEC:

(a) M/S PATRA SHIPPING PRIVATE LIMITED

On scrutiny it is observed that M/S PATRA SHIPPING PRIVATE LIMITED, has submitted all the relevant documents in support of their MSME registration, Audited balance sheet, solvency certificate, experience in similar works, similar work completion certificate etc. Therefore, the firm may be considered technically qualified.

(b) M/S Allied Technologies

On scrutiny it is observed that M/S Allied Technologies, has not submitted relevant documents for qualified in technical bid i.e. Solvency certificate, Work completion certificate, PAN, GST, Registration etc. Therefore, the firm may not be considered technically qualified.

(5) TEC Recommendation:

As per directive from HO retender has been floated. Accordingly technical bid opened on 28-12-2024.

Therefore, considering the above, it is observed that only one bidder, M/s Patra Shipping Private Ltd., has technically qualified. The Hon'ble Minister inaugurated the Cargo Promotion Scheme and Scheduled Service on 15.12.2024.

As the vessels are to be utilized in a fixed schedule service under a bareboat charter with M/s ICSL, it is essential to complete the dry dock repair works at the earliest.

AS per approval of Competent Authority vide e-file computer no. 344725 Note # 190, R.O. level TEC recommends to open the financial bid of the single qualified bidder i.e. M/s Patra Shipping Private Ltd.
