**(4) Observation of TEC:**

**(a) M/s NALANDA ENGINEERING ENTERPRISE**

On scrutiny it is observed that M/s NALANDA ENGINEERING ENTERPRISE, has submitted all the relevant documents in support of their MSME registration, Audited balance sheet, Solvency certificate, Work completion certificate etc. **Therefore, the firm may be considered technically qualified.**

**(b) M/s PATRA SHIPPING PRIVATE LIMITED**

On scrutiny it is observed that M/s PATRA SHIPPING PRIVATE LIMITED, has submitted all the relevant documents in support of their MSME registration, Audited balance sheet, solvency certificate **except**, 1) Banned or de-listed declaration by any GOVT. -or Quasi Govt. agency or public sector undertaking, PSU. **Therefore, the firm may not be considered technically qualified.**

(c) **M/S French Enterprise**

On scrutiny it is observed that M/S French Enterprise, has submitted all the relevant documents in support of their MSME registration, Audited balance sheet, experience in similar works, similar work completion certificate **except**, 1) valid solvency certificate. 2) Declaration of no litigation and/ or any legal discrepancy is pending regarding dry dock land. **Therefore, the firm may not be considered technically qualified.**

(d) **M/S Allied Technologies**

On scrutiny it is observed that M/s Allied Technologies, has submitted many the relevant documents for qualified in technical bid **except**, 1) Solvency certificate with duly signed, 2) Audit Balance sheet and ITR File with duly signed and stamped, 3) Work completion certificate, 4) form of tender, 5) Details of owner/lessee dry dock land / registered lease agreement with the actual recorded land owner, 6) Banned or de-listed declaration by any GOVT. -or Quasi Govt. agency or Public sector undertaking ,PSU, 7) Declaration of no litigation and/ or any legal discrepancy is pending regarding dry dock land. **Therefore, the firm may not be considered technically qualified.**

(e) **M/s GHOSH ENTERPRISE**

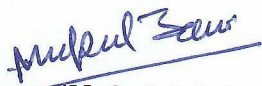
On scrutiny it is observed that M/s GHOSH ENTERPRISE, has submitted all the relevant documents in support of their MSME registration, Audited balance sheet, Work completion certificate, Solvency certificate etc. **Therefore, the firm may be considered technically qualified.**

(f) **M/s RUPNARAYAN MARINE WORKS**

On scrutiny it is observed that M/s RUPNARAYAN MARINE WORKS, has submitted all the relevant documents in support of their MSME registration, Audited balance sheet, Work completion certificate **except**, 1) Solvency certificate duly signed and stamped, 2) Registration certificate of firm duly signed and stamped. **Therefore, the firm may not be considered technically qualified.**

(5) **TEC Recommendation:**

After scrutinizing the six bidders, the TEC observed that two bidders have qualified technically. Therefore, considering the above, the TEC recommends opening the financial bids of the two qualified firms i.e. M/s NALANDA ENGINEERING ENTERPRISE and M/s GHOSH ENTERPRISE.
