(4) Observation of TEC:

(a) MODEL CONSTRUCTION COMPANY

On scrutiny it is observed that M/s MODEL CONSTRUCTION COMPANY, has submitted the relevant documents for qualified technically except, 1) Work completion certificate of adequate amount with duly signed and stamped, 2) ITR Assessment Year 2023-24, 2024-25 duly signed and stamped,

3) All supporting documents duly signed and stamped as per clause technical bid, sl. No. (a), page no. 12, 4) Dry dock land details as per clause, pre-qualification criteria, sl. no. (v), page no. 7, 5) Banned or de-listed declaration by any GOVT. -or Quasi Govt. agency or public sector undertaking, PSU, 6) Bank account detail along with cancel cheque, 7) Valid dry dock land leased agreement as per clause, Pre-qualification criteria, sl. no. (xi), page no. 8.

As per TEC's opinion the shortfall documents were asked to M/s MODEL CONSTRUCTION COMPANY on dated 23.01.2025 through online e-procurement site. M/s MODEL CONSTRUCTION COMPANY has not provided the required shortfall documents therefore, **the firm may not be considered technically qualified.**

(b) **M/s GHOSH ENTERPRISE**

On scrutiny it is observed that M/s GHOSH ENTERPRISE has submitted all the relevant documents in support of their MSME registration, detail Audited balance sheet, experience in similar works, similar work completion certificate etc. However, the solvency certificate of Rs.30 Lakhs cannot be considered, as the same has been used in last three tenders. The details of works are as follows:

Since the firm's solvency amount is lower than the required amount (Rs. 23.96 Lakhs) specified in the tender terms and conditions. **Therefore, the firm may not be considered for technically qualified.**

(c) **M/s B.K. ENGINEERING WORKS**

On scrutiny it is observed that M/s B.K. ENGINEERING WORKS, has submitted the relevant documents for qualified technically except, 1) **The solvency certificate of adequate amount,** 2) The land owner details.

Therefore, the firm may not be considered for technically qualified.

(d) **M/S PATRA SHIPPING PRIVATE LIMITED**

On scrutiny it is observed that M/S PATRA SHIPPING PRIVATE LIMITED, has submitted the relevant documents for qualified technically except, 1) Banned or de-listed declaration by any GOVT. -or Quasi Govt. agency or public sector undertaking, PSU.

 

As per TEC's opinion the shortfall documents were asked to M/S PATRA SHIPPING PRIVATE LIMITED on dated 23.01.2025 through online e-procurement site. M/S PATRA SHIPPING PRIVATE LIMITED **did not respond** with the shortfall documents, and therefore, **the firm may not be considered technically qualified.**

(e) **G. P. ENTERPRISE**

On scrutiny it is observed that G. P. ENTERPRISE, has submitted the relevant documents for qualified technically except, 1) **Valid solvency certificate**, 2) The land owner details, 3) similar work completion certificate of any Govt. work of adequate amount, 4) Not submitted ESIC details, 5) **Udyam certificate not valid for exemption of tender fees and EMD. Therefore, the firm may not be considered for technically qualified.**

(f) **M/S Allied Technologies**

On scrutiny it is observed that M/S Allied Technologies, has submitted the relevant documents for qualified technically except, 1) solvency certificate duly signed and stamped, 2) Audit Balance sheet and ITR File with UDIN along with duly signed and stamped, 3) Work completion certificate duly signed and stamped, 4) Banned or de-listed declaration by any GOVT. -or Quasi Govt. agency or public sector undertaking, PSU, 5) Declaration of no litigation and/ or any legal discrepancy is pending regarding dry dock land, 6) Details of owner/lessee dry dock land / registered lease agreement with the actual recorded land owner, 7) All supporting documents duly signed and stamped as per clause technical bid, sl. No. (a), page no. 12.

As per TEC's opinion the shortfall documents were asked to M/S Allied Technologies on dated 23.01.2025 through online e-procurement site. M/S Allied Technologies **did not respond** with the shortfall documents, and therefore, **the firm may not be considered technically qualified.**

(g) **M/S THE SHALIMAR WORKS (1980) LTD**

On scrutiny it is observed that M/S THE SHALIMAR WORKS (1980) LTD, has submitted the relevant documents for qualified technically except, 1) GST Registration certificate duly signed and stamped, 2) Balance sheet duly signed and stamped, 3) The recent dry dock land agreement details, 4) ITR file duly signed and stamped, 5) Authorization certificate duly signed of 3 directors of company, 6) PAN duly signed and stamped, 7) work completion certificate duly signed and stamped, 8) All supporting documents duly signed and stamped as per clause technical bid, sl. No. (a), page no. 12.

As per TEC's opinion the shortfall documents were asked to M/S THE SHALIMAR WORKS (1980) LTD on dated 23.01.2025 through online e-procurement site. M/S THE SHALIMAR WORKS (1980) LTD has provided the required shortfall documents, and therefore, **the firm may be considered technically qualified.**

(h) **M/s RUPNARAYAN MARINE WORKS**

On scrutiny it is observed that M/s RUPNARAYAN MARINE WORKS, has submitted the relevant documents for qualified technically except, 1) Solvency certificate duly signed and stamped, 2) Registration certificate of firm duly signed and stamped,

3) All supporting documents duly signed and stamped as per clause technical bid, sl. No. (a), page no. 12., 4) Dry dock land details as per clause, pre-qualification criteria, sl. no. (v), page no. 7, 5) Last 3-year Audited Balance sheet with UDIN.

As per TEC's opinion the shortfall documents were asked to M/s RUPNARAYAN MARINE WORKS on dated 23.01.2025 through online e-procurement site. M/s RUPNARAYAN MARINE WORKS **did not respond** with the shortfall documents, and therefore, **the firm may not be considered technically qualified**.

(5) **TEC Recommendation:**

Hence, considering above, as per approval of the competent Authority vide computer no. 371212, note #17, the TEC recommends opening the financial bid of the single qualified bidder i.e. M/s The Shalimar Works (1980) Ltd.
