**(4) Observation of TEC:**

**(a) M/S THE SHALIMAR WORKS (1980) LTD**

On scrutiny after opening of the financial bid of single technically qualified bidder M/S THE SHALIMAR WORKS (1980) LTD based on the comparative statement it is observed that M/S THE SHALIMAR WORKS (1980) LTD has quoted Rs. 19,39,898.40/- which is lower (-1.50%) then the estimated cost.

**(5) TEC Recommendation:**

As per the approval of the competent Authority, R.O. Kolkata TEC opened the financial bid of the single qualified bidder i.e. M/s THE SHALIMAR WORKS (1980) LTD. The TEC observed that M/s THE SHALIMAR WORKS (1980) LTD has quoted Rs.19,39,898.40/- say Rs.19,39,898.00/- plus GST and cost of spare on actual plus 10% basis which is lower (- 1.50%) then estimated cost.

TEC recommends that work may be awarded to single qualified bidder i.e. M/s THE SHALIMAR WORKS (1980) LTD at the quoted price of Rs. 19,39,898.00/- (excluding GST) plus cost of spare on actual +10% basis with approval of Competent Authority.
