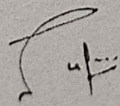


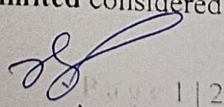
**Minutes of Meeting of the Evaluation Committee under the Chairmanship of CE-NH MPPWD Bhopal held on 21.03.2024 at 04.00PM for evaluation of representation submitted by bidders for the work of "One Time Improvement of existing town portions of Rari, Lapwaha, Bichhondana, Morena, Lahar and Daboh on NH-552 Extn in the State of Madhya Pradesh on EPC mode (Tender ID- 2024\_MoRTH\_789195\_1)**

1. The online tenders for the above-mentioned work through e-tendering Portal <https://eprocure.gov.in/eprocure/app> was called by CE (NH), MPPWD, Bhopal vide Tender ID- 2023\_MoRTH\_789195\_1 on dated 08.01.2024. Bhopal with following bid details: -
  - i. Total length -12.70 km.
  - ii. Total Project Cost – 33.51 Cr.
  - iii. Amount put to tender -25.59 Crore (Excluding GST)
  - iv. Bid due date – 19.02.2024
2. The technical bid were opened by Office of CE (NH), MPPWD, Bhopal on 22.02.2024. The meeting of Evaluation committee for Evaluation of technical Bids was held on 06.03.2024 & result of Technical Evaluation was uploaded on e-Procurement portal on 12.03.2024 for 7 days in which out of total 7 bidders only 03 bidders were found responsive.

3. The representations were received from 03 bidder on the result of Technical Evaluation via Email on [cepwdnhzonemp@gmail.com](mailto:cepwdnhzonemp@gmail.com). The representations have been examined and the Evaluation Committee re-evaluated the Technical Submission based on the points raised in representation.
- 3.1 **M/s Dynamic electricals and switchgear private limited** have submitted the undertaking as per clause 2.11.2(j). Hence, the bid of **M/s Dynamic electricals and switchgear private limited** considered as **Responsive**.
- 3.2 **M/s M K developers and infrastructure** has submitted the required document as per Ministry's circular No. RW/ NH-33044/88/2021 -5&R(P&B)/ DNT (215840) dated 17.01.2022.
- 3.3 **M/s SSB Infratech private limited** has submitted the representation in reference of clause 2.2.2.2(ii) of RFP. In which bidder has requested to consider their Strengthening work in similar nature of work which falls under Noida Municipal limit. The Evaluation Committee has examined the submission and found that the work fulfil the criteria of at least one similar nature of work required as per clause 2.2.2.2(ii) of RFP. Hence, the bid of **M/s SSB Infratech private limited** considered as **Responsive**.
