1. The committee was apprised that the bid , were invited by EE PWD NH Dn-I Jaipur through e-bidding on e-tendering portal. The last date for receipt the bid 14.02.2024. The technical bid of above work was opened on 19.02.2024 and 4 no of bidders participate

2. Evaluation Committee in meeting dated 28.02.2024 has approved the eligibility of 2 bidders after evaluation of the technical bids received from bidders and recommended for the financial opening of the bids of these 2 bidders.

3. Financial Bids of the 2 eligible bidders were opened online on CPP Portal on 06.03.2024 by EE PWD NH Dn.I Jaipur . The details of bids received are as under :

4. Evaluation Committee noted that the bid price of Rs. 2,34,78,500/- quoted by M/s Shubham Enterprises is @ 5.28% above the cost of work put to tender of Rs.2.23 Cr, was found to be the lowest and the Evaluation of bids was found to be in the order mentioned above.

5. In accordance with Ministry Circular No.RW/NH-24035/4/2008 P&M/PIC Vol.II dated 23rd February, 2018, cl 9.1 "In case the tender premium is more than 5% of sanctioned cost (cost put to tender), the revised sanction shall be obtained from the Ministry before acceptance of tender".

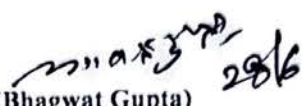

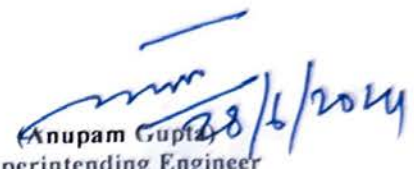
