Note: The bidder has not submitted certificate of compliance as per clause 2.2.1 (d) of RFP and certificate of local content as per clause 1.2.10 and 2.11.1 of RFP. A clarification was asked from the bidder for the same however no response has been received from the bidder. therefore, the bidder is considered as Not Eligible for opening of Financial Bid as per clause 2.2.1 (d) of RFP. The bidder is also considered as Non-Local supplier for non-submission of document as per clause 1.2.10 and 2.11.1 of RFP. Accordingly, it is proposed to carry out the following provision of the RFP before opening of Financial Bid.
