

**Minutes of the Meeting of Evaluation Committee held on 21.02.2024 for opening of bids for "Hiring of Vehicle for MoRT&H, PIU, Machilipatnam".**

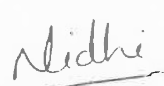

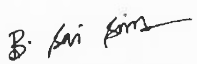
