Venue: Chamber of Superintending Engineer, PWD NH Circle Jaipur.

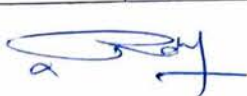

The last date for receipt the bid was 21.02.2024. The Technical Bid for above work was opened by SE PWD NH Circle Jaipur on dated 22.02.2024 in which following 4 Nos bidders participated in this tender: -

 - 4 M/s Nakoda Bhairav Construction.
3. EE PWD NH Division, Ajmer has submitted the technical qualification of bidders and evaluation report of bids of the above work for technical evaluation before the committee for approval.
