2.	Mr. Ajay Kumar	Rs. 25000/-

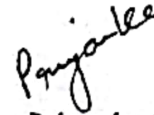
6. The committee noted that Smt. Lalti Devi is the most preferable bidder (L1) for this work.

The meeting ended with Vote of Thanks to the chair.



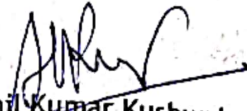
