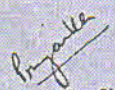
4.3 Further, as per clause 6.1 of data sheet of RFP, the inspection of the offered premises by both the bidders has also been carried out on 13.02.2024.

4.4 Therefore, the above 2 bidders are found to be technically responsive. The details are tabulated as under:

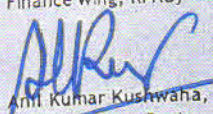
