

MINUTES OF MEETING

Minutes of meeting of Evaluation Committee held on 27.02.2024 at 12.00 PM under the Chairmanship of Additional Chief Engineer Zone NH Jaipur for Evaluation of financial bids for work of Short term maintenance work from KM 14/0 to KM 28/0 (RHS) on NH-248 (Delhi-Jaipur road) in the state of Rajasthan (Job No. NH-248-RJ-JAIPUR-STMC-2023-24-02) with sanctioned cost Rs. 449.23 Lac.

Cost put to tender: - Rs. 449.23 Lac.

2. At outset the Chairman welcomed the participants. The Committee was apprised that the bids were invited by Additional Chief Engineer Zone NH Jaipur PWD Rajasthan, Jaipur through e-bidding on e-tendering portal. The last date for receipt the bid was 24.06.2022. The Technical Bid for above work was opened by EE PWD NH Dn I Jaipur on dated 26.02.2024 in which following 07 Nos. bidders participated in this tender. Evaluation Committee meeting held on 27.02.2024, examined the technical bids as per stipulations given in the bid documents and after deliberations, Evaluation Committee considered following 03 bidders as technically Responsive and recommended for the financial opening of the bids of these three bidders.

3. Financial Bids of the three eligible bidders were opened online on CPP Portal on 05.03.2024 and the relevant documents downloaded from CPP Portal are enclosed. The details of bids received are as under

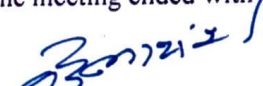

4. The evaluation committee noted that the bid price of Rs. 32694805.11/- quoted by M/s Shubham Enterprises is @ 27.22% below the cost of work put to tender of Rs. 449.23 Lac, was found to be the lowest and the evaluation of bids was found to be in the order mentioned above.

5. In view of the above and in accordance with Ministry Circular No.RW/NH-24035/4/2008 P&M/PIC Vol.II dated 23rd February, 2018, Evaluation Committee recommended to accept the L-1 bidder Shubham Enterprises who quoted the bid of Rs. 32694805.11/- (Rupees Three Crore Twenty Six Lakh Ninty Four Thousand Eight Hundred and Five only) for above mentioned work.

6. Superintending Engineer PWD NH Circle Jaipur is being directed to issue the Letter of Acceptance.
