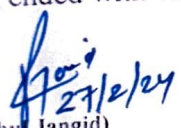
- 1 M/s EQRA International

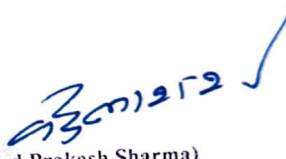
