The Technical Evaluation Committee, consisting of above members met in the office chamber of Executive Engineer, NH Division, Bolangir at 5.00 pm on 07.03.2024 for scrutiny of Cover-I tender documents (Technical Bids) submitted by the participated bidders for the work “FDR to NH-353 such as Construction of RCC Drain, Paver Block, CC Road, Sign Boards & 1 no. of H.P. Culvert from Km 143/140 to Km 143/515 for the year 2023-24”. (Bid Identification No. 05/ EE NH (BGR) of 2023-24. Tender ID No. 2024_MoRTH_792626_1.

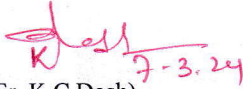
Based on the detailed evaluation of the technical bids of the participated bidders along with the evaluation sheets of all the bidders for the work are placed before the Technical Evaluation Committee and the findings of the Committee are as follows:

Sl. No.	Name of the Bidders	Findings	Remark
1	NITESWAR NAIK, 'C' Class Contractor	The bidder has fulfilled all the minimum eligibility criteria as per Clause No. 122 of DTCN.	Qualified
2.	GUPTESWAR KUMBHAR, 'B' Class (SC) Contractor	The bidder has fulfilled all the minimum eligibility criteria as per Clause No. 122 of DTCN.	Qualified

The financial bid of 02 Nos. of technically qualified bidder (Sl. No. 1 & 2) were placed before the committee. It was found that the bidder at Sl. No. 01 NITESWAR NAIK, 'C' Class Contractor & bidder at Sl. No. 02, GUPTESWAR KUMBHAR, 'B' Class (SC) Contractor have quoted 0.90 % less & 0.50 % less than the estimated cost put to tender for Rs 33,10,196.00 Further, the bidder at Sl. No. 02 has not opted for price preference in the affidavit. Accordingly

the committee unanimously decided to verify the original documents of L1 bidder NITESWAR NAIK, 'C' Class Contractor & issue Letter of acceptance (L.O.A) as clause no. 37 of DTCN .

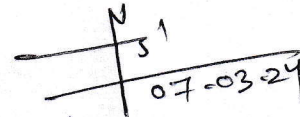
