1. The Administrative & Financial approval and Technical Sanction for the instant work has been accorded by Ministry for an amount of Rs. 19.01 Crore vide letter dated 23.02.2024.

2. The work was bid out in two cover bid system through e-procurement on 08.02.2024 and the technical bids were opened on 22.02.2024.

3. Evaluation Committee examined the documents placed before it. Evaluation sheet is enclosed at Annex-I. Based on the evaluation; committee observed following:

3.1. **M/s Bharat Vanijya Eastern Pvt. Ltd.:** The committee found the bidder as **Technically Responsive** as per **Clause 4** of RFP.

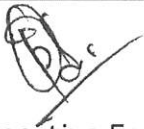
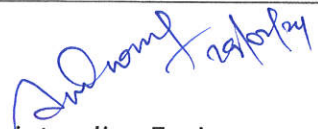
3.2. **M/s GRRB Associates:** The committee found the bidder as **Technically Responsive** as per **Clause 4** of RFP.

3.3 **M/s Tanor Engineering:** The committee observed that the bidder has made misrepresentation by hiding work in value of B. The work Potin-Pangin(Package-5) in which the bidder is a approved subcontractor is still under progress . However, the same is not furnished as existing commitment

of the bidder under calculation of value of B. Hence, committee found the bidder as **Technically Non-Responsive** for materially misrepresenting the information as per **Clause 4.11 (i)** of RFP.

4. In view of the above, the committee found following bidders to be technically responsive and recommended for opening their financial proposals for the work "Performance Based Maintenance Contract (PBMC) on Pasighat-Pangin road section of NH-13 from Km 840.91 to km 855.00 (Total length=14.09km) under Contract Maintenance of NH for the year 2023-24 under Pasighat NH Division in the state of Arunachal Pradesh.(Job No.13/PBMC/Ar.P/2023-24/067)".
