

Minutes of the Meeting held dated: 06/03/24 for evaluation of Technical Bids for the work Short Term Maintenance (STMC) of the left over portion of NH-254 at Kangar Bypass section from Km 53.800 to 57.035 (length 3.235 KM) in the state of Punjab.
(Job No. RO/CH/PB/STMC/254/03 dated: 30.01.2024)

Sanctioned Cost: 1.70 Cr.

(Amount put to tender: Rs 1.32 Cr Without GST)

Meeting of the Technical Evaluation Committee (Constituted by the Chief Engineer (NH), Punjab, PWD B&R, Patiala office Memo No: 3033/NH dated: 18.07.2016) held on Dt. 06/03/24 in the office of Superintending Engineer, National Highway Circle, PWD B&R Br., Ferozepur to evaluate the technical bid as received from Intended bidders as per the Standard SBD document of the Ministry. The following members were present:-

2. At the outset the Superintending Engineer, National Highway Circle, PWD B&R Br., Ferozepur welcomed the participants. Executive Engineer, National Highway Division No.2, PWD B&R, Bathinda appraised about the technical, administrative and financial sanction of the instant project amounting to Rs. 1.70 Cr issued vide Ministry's letter No: RO/CH/PB/W(76)/2023 dated: 18.01.2024. Accordingly, bid was invited by the Executive Engineer through Online Mode vide Tender Notice No: NH-2/BTI/12 dated 29.12.2023 from 29.12.2023 to 24.02.2024 with estimated project construction cost Rs. 1,32,45,247/- (Without GST); Bid Security Rs. 132452/- ; Tender Fee Rs. 11,800/- and Period of completion of 12 Months including rainy season with Three Year Defect Liability Period.

It was intimated to Technical Evaluation Committee that the last date for receipt of bids was 24.02.24. The Hard Copy of original documents of following 06 nos. (Six) bidders were received by 26.02.2024 except one bidder i.e. M/s OSHO Engineering Pvt Ltd, Kotakpura.

The Technical Bid was opened on dated: 26.02.2024 and only Five (05 nos) bidders submitted their bids through both online bidding website i.e. <https://eprocure.gov.in/eprocure/app> & <http://bims.gov.in> , But 02 no Bidders i.e. 1) M/s SF Constructions, Faridkot (2) M/s OSHO Engineering Pvt Ltd, Kotakpura have not submitted their bids on BIMS Portal <http://bims.gov.in>. Details are mentioned below:-

The technical evaluation of the bids for the above Seven (07) nos. bidders was carried out by the Executive Engineer, National Highway Division No.2, PWD B&R, Bathinda and presented before the Technical Evaluation Committee. After detailed deliberations, committee concluded as per the details given below:-

i. M/s RSC Builders, Bathinda

The bidder has submitted bid security amounting Rs. 1,32,500/- vide Demand Draft No: 001071 dated 23.02.2024. In addition to this, Bidder has submitted all necessary documents including tender fee of Rs 11,800/- vide Reference No. 2402240003531 dated 24.02.2024 and Power of attorney. The bidder is meeting all the requirements of qualifying criteria as per STMC SBD. Hence, the bidder M/s RSC Builders, Bathinda is found to be technically responsive.

ii. M/s Varinder Kumar Contractor, Barnala

The bidder has submitted bid security amounting Rs. 1,32,500/- vide Demand Draft No: 003413 dated 22.02.2024. In addition to this, Bidder has submitted all necessary documents including tender fee of Rs 11,800/- vide Reference No. 2402240001554 dated 24.02.2024 and Power of attorney. The bidder is meeting all the requirements of qualifying criteria as per STMC SBD. Hence, the bidder M/s Varinder Kumar Contractor, Barnala is found to be technically responsive.

iii. M/s Amit Construction Co, Shri Ganganagar

The bidder has submitted bid security amounting Rs. 1,32,500/- vide Bank Guarantee No: 58360IGL0000624 dated 23.02.2024. In addition to this, Bidder has submitted all necessary documents including tender fee of Rs 11,800/- vide Reference No. 2402240001249 dated 24.02.2024 and Power of attorney. The bidder is meeting all the requirements of qualifying criteria as per STMC SBD. Hence, the bidder M/s Amit Construction Co, Shri Ganganagar is found to be technically responsive.

iv. M/s Sai Ram Construction Co, Bathinda

The bidder has submitted bid security amounting Rs. 132500/- vide Demand Draft No: 040919 dated 23.02.2024. In addition to this, Bidder has submitted all necessary documents including tender fee of Rs 11,800/- vide Reference No. 2402240011432 dated 24.02.2024 and Power of attorney. The bidder is meeting all the requirements of qualifying criteria as per STMC SBD. Hence, the bidder M/s Sai Ram Construction Co, Bathinda is found to be technically responsive.

v. M/s OSHO Engineering Pvt Ltd, Kotakpura

The bidder has submitted bid security amounting Rs. 1,33,000/- in the form of Fixed Deposit through bidder HDFC Account No. 50300931869166 on dated: 24.02.2024. In addition to this, Bidder has submitted all necessary documents including tender fee of Rs 11,800/- vide Reference No. 7900A0 dated 24-02.2024 and Power of attorney. The bidder is meeting all the requirements of qualifying criteria as per STMC SBD. Further, it is intimated that the bidder has not submitted his Bid online on BIMS Portal which violates the STMC SBD Clause 12.2. Moreover, the bidder has also not deposited Tender Fee Online on Bharatkosh Portal as per STMC SBD requirement and also not submitted his Bid Physically in the office of undersigned. Hence, the bidder M/s OSHO Engineering Pvt Ltd, Kotakpura is found to be technically Non-Responsive.



M/s S F Constructions, Faridkot

The bidder has submitted bid security amounting Rs. 1,32,452/- vide Demand Draft No. 009109 dated: 22.02.2024. In addition to this, Bidder has submitted all necessary documents including tender fee of Rs 11,800/- vide Demand Draft No. 009106 Dt. 22.02.2024 and Power of attorney. The bidder is meeting all the requirements of qualifying criteria as per STMC SBD. Further, it is intimated that the bidder has also not submitted his Bid online on BIMS Portal which violates the STMC SBD Clause 12.2. Moreover, the bidder has not deposited Tender Fee Online on Bharatkosh Portal as per STMC SBD requirement. Hence, the bidder M/s S F Constructions, Faridkot is found to be technically Non-Responsive.

vii. M/s Vishvas Construction Co, Bathinda

The bidder has submitted bid security amounting Rs. 1,32,452/- vide Demand Draft No: 442449 dated 22.02.2024. In addition to this, Bidder has submitted all necessary documents including tender fee of Rs 11,800/- vide Reference No. 2202240009676 dated 22.02.2024 and Power of attorney. The bidder is meeting all the requirements of qualifying criteria as per STMC SBD. Hence, the bidder M/s Vishvas Construction Co, Bathinda is found to be technically Responsive.

Therefore, committee concluded that following 05 (Five) nos. agency should be declared as Technical Responsive and 02 (Two) nos. bidders should be declared as Technical Non-Responsive:

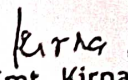
