

Minutes of the Meeting held dated: 13/03/24 for evaluation of Financial Bids for the work "Short Term Maintenance (STMC) of the left over portion of NH-254 at Rampura Phul Bypass section from Km 72.935 to 82.270 (length 9.335 KM) in the state of Punjab"

(Job No. RO/CH/PB/STMC/254/04 dated: 30.01.2024)

Sanctioned Cost: 5.00 Cr.

(Amount put to tender: Rs 3.91 Cr Without GST)

Meeting of the Financial Evaluation Committee (Constituted by the Chief Engineer (NH), Punjab, PWD B&R, Patiala office Memo No: 3033/NH dated: 18.07.2016) held on Dt. 13/03/24 in the office of Superintending Engineer, National Highway Circle, PWD B&R Br., Ferozepur to evaluate the financial bid as received from Intended bidders as per the Standard SBD document of the Ministry. The following members were present:-

2. At the outset the Superintending Engineer, National Highway Circle, PWD B&R Br., Ferozepur welcomed the participants. Executive Engineer, National Highway Division No.2, PWD B&R, Bathinda appraised about the technical, administrative and financial sanction of the instant project amounting to Rs. 5.00 Cr issued vide Ministry's letter No: RO/CH/PB/W(76)/2023 dated: 18.01.2024. Accordingly, bid was invited by the Executive Engineer through Online Mode vide Tender Notice No: NH-2/BTI/12 dated 29.12.2023 from 29.12.2023 to 24.02.2024 with estimated project construction cost Rs. 3,90,61,605/- (Without GST); Bid Security Rs. 390616/- ; Tender Fee Rs. 11,800/- and Period of completion of 12 Months including rainy season with Three Year Defect Liability Period.

It was intimated to Technical Evaluation Committee that the last date for receipt of bids was 24.02.24. The Hard Copy of original documents of following 05 nos. (Five) bidders were received by 26.02.2024 except one bidder i.e. M/s OSHO Engineering Pvt Ltd, Kotkapura

- 1) M/s Vishvas Construction Co, Bathinda
- 2) M/s RSC Builders, Bathinda
- 3) M/s Varinder Kumar Contractor, Barnala
- 4) M/s Amit Construction Co, Shri Ganganagar.
- 5) M/s Sai Ram Construction Co, Bathinda
- 6) M/s OSHO Engineering Pvt Ltd, Kotkapura

The technical bids of all above mentioned bidder have been evaluated on Dt. 06.03.24 as per the Terms & Conditions of the STMC SBD and it was found that 05 (Five) nos. bidders are Technically Responsive & 01 (One) no. bidder are Technically Non-Responsive. In view of the above, the Technical Evaluation Committee decided to allow the opening of Financial Bid of above 05 (Five) nos. technically Responsive bidders on Dt. 12.03.2024 in the office of Executive Engineer, National Highway Division No.2, PWD B&R, Bathinda.

Accordingly, the Financial Bids of technically Responsive bidders have been downloaded on Dt. 12.03.2024 and the BOQ/Rate quoted by 05 no. bidder is received as under:-

As per comparative financial statement the rate quoted by M/S Varinder Kumar Contractor, Barnala are lowest [(-) 24.17 %]. The amount quoted by the M/S Varinder Kumar Contractor, Barnala is evaluated & compared with DNIT amount and found that there is saving of Rs. 94,41,189.14/- from approved DNIT amount.

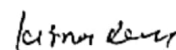
In view of the above, Financial Evaluation Committee allowed to process the Tender Case in favour of M/S Varinder Kumar Contractor, Barnala at the Price of Rs. 2,96,20,415.86/- with time limit of 12 Months (12) with Defect Liability Period of 03 years including rainy seasons.
