

MINUTES OF MEETING OF TECHNICAL EVALUATION COMMITTEE HELD ON 02-07-2024 FOR THE WORK "Maintenance works and activities (PBMC) on section from Km. 58/400 to 100/0 (Gagret to Chouli) on NH-70 (New NH-03 in the State of Himachal Pradesh."

1. The meeting of the Evaluation Committee for the evaluation of technical Bids for the work of "Maintenance works and activities (PBMC) on section from Km. 58/400 to 100/0 (Gagret to Chouli) on NH-70 (New NH-03 in the State of Himachal Pradesh" was held on 02-07-2024.
2. The Executive Engineer, NH Division, HP.PWD., Hamirpur informed the Committee that total ten no. of bids have been received for the work and all the bidders have uploaded their Technical bids on BIMS portal. Further as per the evaluation of bids on BIMS portal, all the bidders have been found non-responsive and further it was observed that it happened due to the reason that the bidders have not entered the data correctly. Since Ministry has made it mandatory to evaluate the bids online on BIMS Portal, the Committee deliberated the issue and keeping in view the urgency of the work, the Committee decided to carry out the manual technical evaluation for both the bids.
3. The Executive Engineer, NH Division, HP.PWD, Hamirpur further informed the Committee that the Bank Guarantee submitted towards bid security by all the bidder have been confirmed from the respective bank and is found to be correct and in order.
4. The Committee conducted the technical evaluation as per evaluation criteria mentioned in the tender documents. The outcome of technical evaluation is as below:
