

Minutes of the Meeting of Evaluation Committee for Evaluation of Technical Bid for PBMC Work of NH-22 (Old NH-99) Dobhi-Gosaidih road from Ch 0+000 to Ch 11+400 for the year 2023-24 (Job No-119(Old NH 2C) NH-22(Old NH -99)NH-33(Old NH-110)/BR/2023-24/98) in the state of Bihar under N.H. Division, Gaya held on 28.05.2024 in the office of Chief Engineer, NH (South) Wing RCD, Bihar Patna.

Amount put to Tender: -Rs 12.8006 Cr.

The above-mentioned work was sanctioned by Ministry vide reference no.- RW/PAT/NH/Estimate/PBMC/NH Gaya/2023-24 (Comp. No 234031) dated 05.03.2024. The amount put to tender for the aforesaid work was Rs 12.8006 Cr.

2. The bid was invited online by Executive Engineer, NH Division, Gaya vide NIT No.-08 NHD/GAYA dated 26.02.2024 on e-procurement site with bid due date 19.03.2024, which was further extended to 03.04.2024 vide Corrigendum-1 dated 19.03.2024. The date of opening of technical bid was fixed on 05.04.2024 at 15:30 Hrs.

3. Tender was opened online on 05.04.2024 by Executive Engineer, NH Division, Gaya in which the following 04 (four) bidders have participated:-

4. The Evaluation Committee on 07.05.2024 examined the bids and declared the bid of following two (2) bidders as responsive: -

5. The Evaluation Committee was informed that the technical result was uploaded on the CPP Portal as per the provisions of RFP on 15.05.2024 as decided by the Evaluation Committee in its meeting held on 07.05.2024.

6. The Evaluation Committee was informed that out of two non responsive bidders, one bidder namely **Jai Maa Ambe Infra Private Ltd, Address- Chatra, Jharkhand** has submitted representation claiming to be technically responsive.

7. The Evaluation Committee, on 28.05.2024 examined the representation received from the bidder in detail. Following were the representation of the bidder and observations made by the committee:-

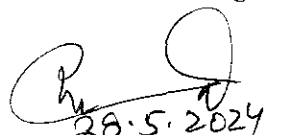
Sr. No.	Name of bidder(s)	Representation	Remarks of Committee
1.	Jai Maa Ambe Infra Private Ltd Address- Chatra. Jharkhand	The bidder has submitted that our bid is rejected but the required paper as per the tender document i.e. Bid Capacity, Net worth, supporting with audit report by the CA and the other document is already submitted by us. Also requested to consider my bid as responsive and to verify the authenticity qualifying paper of another bidders before finalizing the above tender.	Non-Responsive (As the bidder has not submitted information required to evaluate the bid capacity, net worth which must be submitted by bidder duly authorized by the statutory auditor as per clause 4.2 of RFP Document and Technical Personnel. Qualification are not as per clause 4.1 j(2) of RFP. (CVs and Certificate not attached.) The evaluation committee has already examined all the documents of participated bidders and based on above, declares Jai Maa Ambe Infra Private Ltd as non-responsive since bidder fails to fulfill the criteria as per clause 4.2 and 4.1 j(2) of RFP.

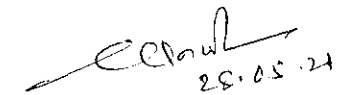
8. Based on para-7 above, the Evaluation Committee recommends to declare the following bidders as technically responsive:-

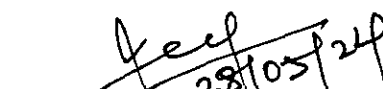
