

Minutes of the Meeting dated 19.06.2024 for evaluation of Financial Bids for the work of "Performance based Maintenance Contract (PBMC) for NH-703 Barnala -Mansa- Sardulgarh upto Haryana Border (Length 27.425 Km.) in the State of Punjab for the year 2023-24 (Job No. NH-703-PB-2023-24-574)"

Sanctioned Cost: Rs. 46.85 Cr

(Amount put to tender: Rs. 34.71 Cr. excluding GST)

Meeting of the Financial Evaluation Committee held on dated 19-06-2024 in the office of the Chief Engineer (NH), Punjab, PWD (B&R) Branch, Patiala to finalize the evaluation of the Financial Bids as received from the intended bidders as per the standard RFP documents of the Ministry. The Evaluation Committee was constituted by MoRT&H, New Delhi vide circular/guideline No. RW/NH-24035/4/2008-P&M/PIC Vol.II dated 23.02.2018 and following members were present:

2. At the outset, the Chief Engineer (NH), Punjab, PWD (B&R) Branch, Chandigarh welcomed all the participants. Member Secretary apprised the members of the Committee that, as per the meeting of the Technical Evaluation Committee held on 06.06.2024, Five (05) bidders were declared technically responsive out of Seven (07) Bidders that participated in the bids. It was also decided by the Committee in the meeting that the financial bids of the above said Technically Responsive bidders will be opened on 18.06.2024 at 11.00 AM.

3. In the meeting dated 06-06-2024, it was also decided that as per RFP, all the responsive bidders are directed to furnish the updated Bid Capacity status in the prescribed format enclosed at Annexure-VI of Appendix-IA of RFP for any change in their bid capacity, due to award and emerged as the winner of bid but LOA has not been issued as on the day before opening the financial bid shall also be considered while calculating value of B. In case of no change, 'NIL' information shall be furnished. The requisite information should be submitted by 18-06-2024 upto 10:00 Hrs positively through email eecwdbtipwdpb@gmail.com. Accordingly, member secretary informed that the updated value of Bid Capacity Status of all technically responsive bidders has been received and after examination of the same, all bidders were found Responsive.

4. It was intimated to the Evaluation Committee that the financial bids of Five (05) technically responsive bidders were opened through <http://eprocure.gov.in/eprocure/app> in the office of Member Secretary on 18.06.2024. The rates quoted by Technically Responsive Bidders in their Financial Bids have been downloaded from website and accordingly, the financial position in respect of each bidder is as follows:

5. The Executive Engineer-cum-Member Secretary has explained the financial position of this project as under:

- A) RFP Cost : Rs. 347059510.00 (Excluding GST)
 B) Lowest Bid Cost : Rs. 204383345.44 (Excluding GST)
 C) Cost Below the amount put to tender : 41.11% Below the RFP Cost

6. The Committee has observed that the quoted price of Rs. 204383345.44 (**Rs. Twenty Crore Forty three Lacs Eighty Three Thousand Three Hundred Forty Five and Paise Forty Four only**) excluding GST by **Shivam Construction Co., Malout** is lowest among all the Five (05) Technically Responsive financial proposals is 41.11 % (Forty One point Eleven percent) below the Cost put to tender i.e. Rs. 347059510.00 (Excluding GST).

7. The Committee agreed for the award of work to the lowest bidder **Shivam Construction Co., Malout** at quoted price of **Rs. 204383345.44 (Rs. Twenty Crore Forty three Lacs Eighty Three Thousand Three Hundred Forty Five and Paise Forty Four only)** excluding GST, subject to seeking written clarifications from the bidder in terms of detailed price analysis of its bid price in relation to scope, completion schedule, allocation of risks and responsibilities, safety requirements as well as subsequent demonstration of its capability to complete the work at the offered price as decided by the bid accepting authority.

8. The Committee also deliberated the matter related to 3% Performance Security along with the additional Performance Security and recommended to follow the instructions as per Clause 28 of ITB of approved RFP.
