1. The Administrative & Financial approval and Technical Sanction for the instant work has been accorded by Ministry for an amount of Rs.53.35 Crore vide letter dated 12.03.2024.

2. The work was bid out in two cover bid system through e-procurement on 29.02.2024 and the technical bids were opened on 15.03.2024.

3. The evaluation committee examined the document placed before the committee. Evaluation sheet is enclosed at Annex-I. Based on the evaluation; the committee observed the following:

3.1. **M/s Dineshchandra R.Agrawal Infracon Pvt. Ltd:** The committee found the bidder as **Technically Responsive** as per Clause 3.1.6 of RFP.

3.2. **M/s GRRB ASSOCIATES:** The committee found the bidder as **Technically Responsive** as per Clause 3.1.6 of RFP.

3.3. **Spar Geo Infra Pvt. Ltd.:** The committee observed the following:
The bidder has not furnished additional experience in the execution of work using new technology for land-slide mitigation involving "Construction of Road over Micro-piles" as per clause 2.2.2.2(ii) of the RFP. Hence, the committee has found the bidder to be **Technically Non-Responsive as per Clause 2.2.2.2(ii) of the RFP.**

4. In view of the above, the committee found the following 2 (two) bidders to be technically responsive and recommended for opening their financial proposals for the :Work at km 17.650, km 22.150, km 30.960, km 37.400 on NH-13 and km

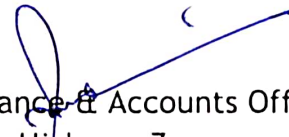
