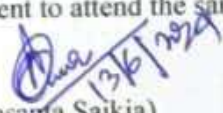

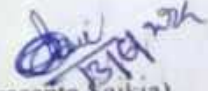

(ii) **Pre-bid Meeting:** The Pre-bid meeting was held on **08.03.2024** from 12.00 hrs. to 14.00 hrs. as per schedule. No bidder attended the meeting.

(iii) **Date stipulated for receiving the bid document:** The deadline for submission of online bid was up to 14.00 hours on 22.03.2024

(iv) **Date & time of opening of online Technical Bid:** 26.03.2024 at 14.00 hrs

Receiving of Bids: 2(Two) no bids were received through online mode in the official e-tendering portal of <https://eprocure.gov.in> till the deadline time i.e. 14.00 hours on 22.03.2024

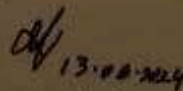

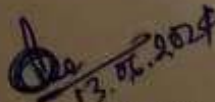
