

Minutes of Meeting of Screening Committee held on 14.06.2024 at 03:00 PM. through hybrid mode for the screening of the technical bids as carried out by the State Level Evaluation Committee for the work of "Upgradation to two-lane with paved shoulder of Hanumangarh to Kenchiyan from km 0.000 (existing chainage Km 23.200) to Km 49.605 (existing chainage Km 74.645) of NH-54 in the state of Rajasthan on EPC mode."

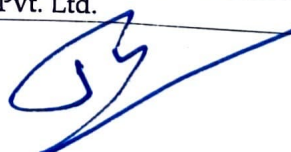
2. At the outset, the Chief Engineer (North-II), MoRTH, New Delhi welcomed all the participants. The Committee was apprised that the technical, administrative and financial sanction to the instant project amounting to Rs. 334.64 Cr was issued by Ministry's letter No. RW/JAI/RJ/CE-RO/NH-12014/2021-22/38/ (Comp No. 206559) date 06.03.2024

3. Bids for the work with civil Construction Cost & Utility shifting cost of Rs. 252.24 crore (including GST) were invited by the Superintending Engineer PWD NH Circle Bikaner Rajasthan, vide NIT No. 03/2023-24 dated 02.03.2024 through Central Public Procurement Portal (CPPP) as per delegation. Last date of bid submission was 18.04.2024. The bid due date was extended vide corrigendum No.02 dated 15.04.2024 & Corrigendum No. 03 dated 26.04.2024 up to 06.05.2024.

4. Thereafter the technical bids were opened on 07.05.2024 in the presence of State level Evaluation Committee. Eleven nos of bidders have participated as per the following details:

5. The meeting of State Level Committee under the Chairmanship of Chief Engineer (NH), PWD Rajasthan was convened on 29.05.2024. The Committee evaluated the bids on 29.05.2024 as per RFP and it was found that out of 11 bidders, 10 nos. of bidders fulfil the eligibility requirements of RFP and 01 nos. of bidders as detailed below don't meet the eligibility requirement:

- (a) M/s Ganesh Builders JV with All Grace Developers Pvt. Ltd. has not submitted the Valid Joint bidding Agreement as per RFP Clause 2.1.6 & 2.1.11(f) and also not submitted Signed Integrity pact by Authorised Signatory (format Appendix VI) as per RFP Clause 2.11.1(j). Therefore, the bidder has been considered non responsive.

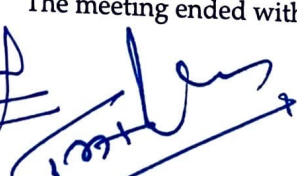
6. The Screening Committee deliberated on the evaluation done by the State Level Evaluation Committee. It was observed that Tags Project Pvt. Ltd., other member of M/s Krishna Constellation Pvt. Ltd with Tags Project Pvt. Ltd. (JV). does not meet Threshold Technical Capacity of 20% criteria as per clause 2.2.2.4(i) and 2.1.11 (c) of RFP. Accordingly M/s Krishna Constellation Pvt. Ltd with Tags Project Pvt. Ltd. (JV) is declared as Non-responsive.

7. Screening Committee recommended that the financial bids of following Nine (09) numbers of technically responsive bidders may be opened after publishing the result of Technical Evaluation on e-procurement website as per Clause 3.1.9 of RFP.

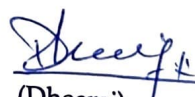

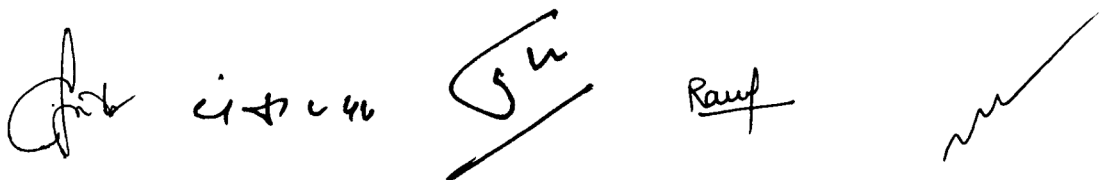

Further, In pursuant of MoRTH GOI New Delhi guidelines issued vide letter No. NH-24035/4/2008-P&M/PIC Vol-II dated 23.02.2018, the evaluation has been carried out by the Evaluation committee as per composition in Table-2 (clause 8.3) of circular. Hence the evaluated bids are submitted for further examination by the screening committee at MoRTH headquarter in accordance with the noted circular.

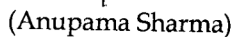

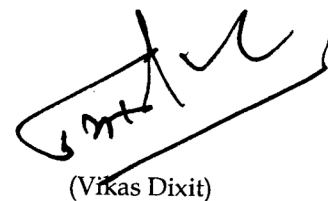
