Meeting of Evaluation Committee was held on Date.26/04/2024 in the Chamber of Chief Engineer (NH) & Addl. Secy., Roads & Building Dept., Block No.-14, 1st Floor, New Sachivalaya , Gandhinagar for the evaluation of the Technical Bids of the bidders. The following Committee members were present:

2. At the outset, the Chief Engineer (NH) & Addl. Secy. welcomed the participants. The Committee was appraised that the technical, administrative and financial sanction to the instant work amounting to Rs.47.51 Crore was issued vide Ministry's letter No. NH/12014/122/2023 / GJ/RO Gandhinagar C-232010, dated 15.01.2024.

3. EE N.H Division Gandhidham apprised that the civil cost of the work is Rs. 36.74 Cr. Bid was invited by the State Government through e-bidding on CPPP as well as BIMS portal of the Ministry. The last date for receipt of bids was 24.04.2024 and bids were opened on 24.04.2024. The details of the bidders submitted their bids for the work are as under:

The Committee observed that Above all bidders qualify preliminary criteria such as submission of Bid security Declaration, tender fee, And Power of attorney etc. It is also found that automatic Bid evaluation through BIMS is not working. The EE N.H Division Gandhidham apprised that as enquired from the BIMS Helpdesk "At present Technical evaluation is not being done through Portal". Therefore, The Committee decided to download valid documents of the bidders from the BIMS portal for evaluation of bids in the conventional manner.

5 The Committee noted after detailed evaluation of technical bid that out of Three (3) bidders, M/s. Dhanjibhai K. Patel, Anjar, does not fulfill (Technical Capacity) Qualification criteria. Therefore, Evaluation Committee declared M/s. Dhanjibhai K. Patel, Anjar, as technically non-responsive and other Two Bidders technically Responsive. The details of technically Responsive & Non Responsive bidders is as follows.

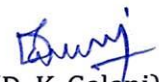
