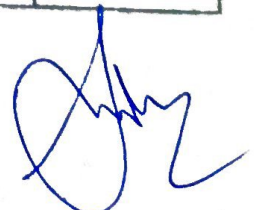
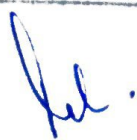

3. The findings of the Evaluation Committee were uploaded in the e-procurement portal on 20.06.2024 and bidders were given opportunity to respond within 7 days in case they have any objection. Thereafter, no representation was received by the bidders. Accordingly, the financial Bid of the above 2(Two) technically responsive bidders was opened on 28/06/2024. The quoted price of the bidders was downloaded and the quoted prices are as tabulated below:

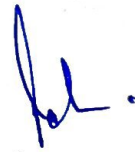

Rs. 30,01,80,874.00/- which is almost equal to the cost put tender for the work of "Performance Based Maintenance Contract (PBMC) to NH-37 from Km 0.560 to Km 3.220 (length = 2.660 Km) & NH-202 from Km 465.200 to Km 488.000 (length = 22.800 Km) under National Nighway Division No. III, PWD, Manipur in the state of Manipur" subject to the condition mentioned in the technical evaluation minutes i.e. the successful bidders shall ensure the deployment of key personnel as per RFP before award of work.
