Minutes of the Meeting of Tender Evaluation Committee held on 18th June, 2024 at 13.00 Hrs for the work, "Performance Based Maintenance Contract(PBMC) to NH-37 from Km 0.560 to Km 3.220 (Length = 2.660 Km) & NH-202 from Km 465.200 to Km 488.000 (Length = 22.800 Km) under National Highway Division No. III, PWD, Manipur in the State of Manipur."

The work under consideration was sanctioned by the Ministry amounting to Rs.33.04 Cr vide Sanction letter No.NH-12014/22/2024-Ro-Guwahati (C. No. 234050) dated 23rd February 2024. The estimated civil construction cost of work is Rs. 30.02 Cr. The work is proposed under EPC mode by the State PWD, Manipur as per Ministry's laid down procedures.

2. As per Ministry's Circular no. RW/NH-24035/4/2008-P&M/PIC Vol. II dated 23.02.2018 for works with sanction cost more than Rs. 5.00 crore to Rs. 100 crore, tender may be invited by the state PWD using requisite bidding document and procedure as per ministry's extant guidelines. 3. The tender for the above mentioned work amounting to Rs. 30.02 crores (amount put to tender) was invited by the Chief Engineer PWD, Manipur on 5th March 2024 and opened on 10th April, 2024. 4. The Bidder in Sl. No. 1, Kh. Kalachand Singh, Thangmeiband Khondram Selungba Leikai, Imphal West District, Manipur-795004 and the Bidder in Sl. No. 2, KH. Jiten Singh, Uripok Khaidem Leikai, Imphal West District, Manipur-795001 have not submitted the physical copy of

the bid. The committee opined to reject the bids of the both bidders at the instant without evaluation of the bid as per clause 12.2 of RFP.

6. As per Clause 4.3 (i), for demonstrating of the Threshold Technical Capacity a project is considered as an 'Eligible Project' under Categories 1 and 3 if the work executed is certified by the Engineer-in-charge/Independent Engineer/Authority's Engineer and the amounts (gross) actually received/ work executed, during such 5 (five) financial years preceding the Bid Due Date is more than of Rs.30.02 Cr.

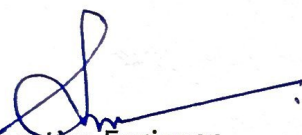
7. As per Clause 4.3 (ii) for normal highway projects, at least one similar work of cost more than Rs. 6.00 Cr (i.e 20% of estimated project cost) only shall have been completed from the Eligible projects in Category 1 and / or category 3.

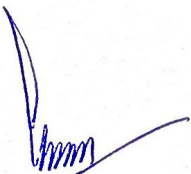
