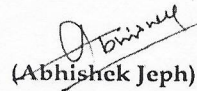
IV. It is observed by the evaluation committee that 05 (Five) bidders are technically responsive and 01 (One) bidders are found technically non-responsive.

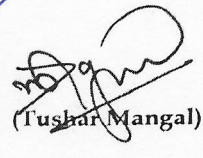

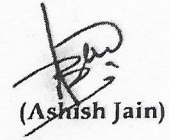
