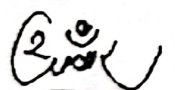

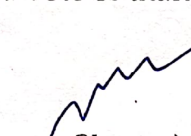
IV The Evaluation Committee evaluated the financial bids during its meeting held on 10.07.2024 (online/offline). it is observed by the evaluation committee that the lowest tendered amount of Rs. 16,14,200,00.00 /- (Rs. Sixteen Crore Fourteen Lakh Twenty Thousand Hundred only) has been quoted by M/s Preeti Buildcon Pvt. Ltd., , which is 30.00% Below on sanctioned civil work cost (based on NH Circle Jodhpur BSR April,2019 put to tender).

V. After deliberations, Evaluation Committee recommended award of bid to lowest bidder M/s Preeti Buildcon Pvt. Ltd., at a cost of Rs. 16,14,200,00.00 /- (Rs. Sixteen Crore Fourteen Lakh Twenty Thousand Hundred only) as quoted by M/s Preeti Buildcon Pvt. Ltd, which is 30.00 % Below subject to submission of additional performance guarantee as per RFP clause 2.2.1.
