IV. The Evaluation Committee evaluated the financial bids during its meeting held on 07.06.2024 it is observed by the evaluation committee that the lowest tendered amount of Rs. 5,81,00,000/- (Rs. Five crores Eighty-One lacs only) has been quoted by M/s Vijay Kumar Contractor which is 29.7783% Below the amount put to tender (based on NH Circle Bikaner BSR April 2019 put to tender).
